Abstract Submission Requirements

Presentation Type: Podium, Poster, Podium OR Poster, Panel, Pre-Conference Workshop (select the one for which you wish to be considered)

Presentation Category: Policy, Practice, or Administration (select one)

Abstract Title: Please state the title of your abstract. If your presentation is selected, this is the title that will be displayed on the web site and in the conference program.

Purpose/Goal Statement: Clearly state the purpose of your presentation. This information will be posted to the web site and will be included in the printed conference program. (Be as concise as possible.)

Relevance to conference theme and objectives: (30 words maximum)

Abstract: 300-word limit. Please do not reiterate information found in other fields of this abstract submission system.

Blinded Abstract: This should be a copy of the above submitted abstract without ANY identifying information such as name, organization, affiliation, etc. (At the top of this abstract, please include ONLY the credentials of the primary presenter.)

Outline: Content outline of the session to include

- 1. Introduction
- 2. Body of presentation
 - a. Example: stakeholders
 - b. Example: findings
 - c. Example: barriers
- 3. Conclusion
 - a. Example: recommendations
 - b. Example: community impact
- 4. Questions
 - a. Allow for 5-10 minutes for questions and discussion
